

TERMS AND CONDITIONS OF PARTICIPATION

LINGOT D'OR CONTEST

By entering this contest, you agree to the following terms and conditions.

- 1. Only individuals who have spent at least two consecutive nights at one of our partner hotels* in Villars-Gryon-Les Diablerets-Bex between 1 July and 31 August, 2020, at 12noon are permitted to participate.
- 2. Only individuals who have completed their 18th year on the first day of their stay are allowed to participate.
- 3. Only one entry per person and stay is permitted.
- 4. Each participant will receive from his/her hotel a numbered voucher containing an entry code.
- 5. Each participant must register his/her entry by filling out the form at www.villars-diablerets.ch/contest using the code on the voucher provided by the hotel partner.
- 6. Partners and members of the Association Touristique Porte des Alpes, as well as their relatives (parents, children, spouses), are excluded from the contest.
- 7. Employees of partner hotels participating in the competition are also excluded from the contest.
- 8. Any falsely or erroneously provided details or codes contained on the voucher shall result in the exclusion of the participation.
- 9. Unless otherwise indicated by the customer, the data will only be used in the context of this contest. They will be treated confidentially and will not be passed on to third parties.
- 10. Only the winners will be personally notified by registered mail. No correspondence involving the contest will be entered into.
- 11. First prize is a 1kg gold bar with a value of CHF 53'619.73 (price as of 26 June, 2020). Second prize is a 2-night stay in a double room with complimentary breakfast for two at a 4-star hotel. Third prize is a 1-night stay in a double room with complimentary breakfast for two at a 3-star hotel.
- 12. The draw will take place on Tuesday, 8 September, 2020, under the supervision of a notary public. Three voucher numbers will be drawn, and the results confirmed by the notary will be final and binding.
- 13. If any of the winners fail to respond within 30 days after notification, the prize(s) will be redrawn.
- 14. Failure to comply with these terms and conditions will result in the cancellation of participation.
- 15. In the event of a dispute, the exclusive place of jurisdiction shall be the registered office of the Association Touristique Porte des Alpes, Villars-sur-Ollon, and this contest shall be governed by Swiss law.
