## **RIGHTS AND DUTIES OF DRIVERS OF MOBILE HOMES**

The use of mobile homes as a means of transport has to be in accordance with the road traffic regulations applicable for this category of vehicles.

Their use as a home requires respecting some rules regarding the inhabitants of the places visited.

In city centers or urban environments, mobile homes should be parked:

- where the population is less dense
- not obstructing visibility and commercial activity
- in such a way that the size of the mobile home will not hinder traffic

Also, the use of mobile homes for habitation should be:

- without trespassing the space outside of the vehicle
- without creating a nuisance for the local residents
- without monopolization of the public space
- supervising any pets so as to avoid troubles and soiling

Waste water has to be disposed of as follows:

- at the appropriate places and by no means near habitations, running water or cultured fields.
- the disposal of black water (toilet) into the rain water system is strictly forbidden.

When on the road, all water drainage taps have to be closed.

Even the disposal of clean water has to be done discreetly in order not to create suspicion.

It is of advantage to be informed about the local facilities for disposals so that those can be carried out in good order.

The disposal of household waste has to be in the official bags and at the places intended for this.

By respecting these common sense principles, everyone will be able to fully enjoy the pleasure of traveling by mobile home.
