THE CHARTER

I. GOAL

Article 1 The club's goal is to create a circle of people who enjoy Nendaz, and wish to participate in the smooth development of the region by improving its infrastructures and its promotion. This club supports the activities of Nendaz Tourisme.

Article 2 The club is open to all and is always in search of new members. It wishes above all to be a fun and friendly organisation.

II. THE MEMBERS

Article 3 All persons who pay the annual fee may become a member of the club. Each member can invite a 'guest' to have the same advantages as the members.

Article 4 The member applications are to be made at Nendaz Tourisme.

Article 5 If the annual fee is not paid, the member will be excluded from the club. All the advantages allowed to the member are also cancelled.

III. ADMINISTRATION AND REPRESENTATION

Article 6 Nendaz Tourisme manages the administrative aspect of the club. Nendaz Tourisme is represented by its director.

Article 7 A decision making committee consists of three members and the representative of Nendaz Tourisme.

IV. FINANCIAL RESOURCES

Article 8 The financial resources come from:

1. The members' fees
2. The revenue from its fortune
3. Donations and other funding.

Article 9 The members' fee is CHF 250 per tourism year (from 1st November to 31st October) for a member, including a 'guest card' with the same advantages.

Article 10 Part of this revenue will be invested in various projects as mentioned in article 1 of the charter. Another part will be used to pay for the special advantages available to the members.

Article 11 The commitments made by the organisation can only be guaranteed if there are sufficient funds.
